1. Request an OVP authorization form from your supervisor, safety officer or H.R. department. Your company may cover all or most of the costs.
2. Choose an OVP optometrist at www.ovp.bc.ca or call 1-866-687-2226. OVP optometrists are located in more than 85 communities across B.C.
3. If you already have a valid eyewear prescription*, bring it along to the appointment.

*A valid prescription is one signed by an optometrist or ophthalmologist and is dated within the last two years. If your prescription is more than two years old, call to make an appointment today. The optometrist will conduct an eye examination to assess your current vision and eye health.
